JDE Peet's share buyback periodic update June 30, 2025

JDE Peet's (EURONEXT: JDEP), the world's leading pure-play coffee and tea company, today announced that it has repurchased 15,429 shares in the period from June 23, 2025 up to and including June 27, 2025.

The shares were repurchased at an average price of EUR 24.10 per share for a total consideration of EUR 0.4 million. These repurchases were made as part of the EUR 250 million share buyback programme [announced on March 3, 2025](#).

The total number of shares repurchased under this programme to date is 3,773,550 ordinary shares for a total consideration of EUR 71.1 million. More details on the progress of the buyback programme are available [here](#).
