BGHL is a closed-ended investment company which invests in BG Fund, Boussard & Gavaudan's flagship fund with 20 years of track record.

BGHL's investment objective is to deliver an annual return, net of fees, of 400 to 600 basis points above the risk-free rate over the business cycle, irrespective of market performance. The risk-free rate is "Compounded euro short-term rate index" ⁽¹⁾.

BG Fund is driven by bottom-up fundamental and event catalyst research, combined with extensive multi-asset arbitrage and derivative expertise. Typically, investment ideas are catalyst driven with a focus on special situations and events.

Capital is dynamically allocated to the firm's best ideas and these ideas are categorized into four main types of strategies: Equity, Volatility, Credit and Trading strategies.

II. OVERVIEW

Boussard & Gavaudan Holding Limited (“BGHL”) is a Guernsey closed-ended investment company and is registered with the Dutch Authority for the Financial Markets as a collective investment scheme under article 1:107 of the Dutch Financial Markets Supervision Act. BGHL invests its assets in order to provide exposure to multiple alternative investment strategies managed by the Investment Manager. The investment objective is to produce long-term appreciation of its assets. BGHL seeks to achieve this by investing in BG Fund (“the Fund”). In addition, a proportion of the net assets of BGHL may, at the discretion of the Investment Manager, be invested in other hedge funds and financial assets selected by the Investment Manager. BGHL aims to generate a target NAV annualized return of Eonia capitalized + 400/600 bps over the business cycle, net of all fees.

V. BGHL COMPOSITION

BGHL is invested in BG Fund (net of an amount retained by BGHL for working capital and other requirements).

As of 1 May 2024, 99.73% of BGHL net asset value is invested in BG Fund. BGHL has a maximum exposure limit to BG Fund of 110%. The remained BGHL net asset value is made up of direct investment and cash.

A. BG FUND

April 2024 HIGHLIGHTS

Renewed expectations of higher for longer interest rates led to a reversal in equity market bullishness in both Europe and the US. The EuroStoxx 50[®] Total Return and the S&P500[®] Total Return fell by -2.44% and -4.08% respectively over the month.

Broader market stress was limited and the market implied volatility measure VStoxx[®] increased only slightly, finishing the month at a still-low 15.6% and the iTraxx Crossover[®] (S39) moved slightly wider from 297bps to 318bps.

Against this backdrop, BG Fund was up +54bps (USD A shares) for the month with positive performance from events in credit strategies as well as volatility strategies.

April 2024 COMMENTARY

Volatility strategies

Mandatory convertible bond arbitrage

Mandatory convertible bonds contributed +12bps this month with performance from a general repricing. The new issue market remains frustratingly quiet and with only one remaining mandatory convertible in Europe we are overdue a new transaction. We anticipate new issues will arrive with the revival of the M&A market.

Convertible bond arbitrage

Convertible bond strategies contributed +7bps in April.

In Europe, primary markets remain quiet with the positive performance explained by a small repricing of volatility positions. Conversely, the Japanese primary market showed increasing activity and we took the opportunity to add to our volatility arbitrage positions in the region. The Japanese CB market has remained relatively unattractive for a while due to a low number of new issues however this dynamic seems to be changing.

The US convert market was weak in April with spreads and yields wider across the curve; HY CDX increased from 330 bps to 357 bps, 2-year yields rose from 4.62% to 5.03% and 5-year yields climbed from 4.21% to 4.71%. April also saw the VIX rise from 13.01% to 15.65%, but the offsetting benefits of rising volatility were outweighed by interest rate and credit spread movements. While our performance was negative, we outperformed most arbitrage funds due to the defensive nature of our portfolio. There is more optimism at the beginning of May due to the dovish tone of the Fed's press conference on 1st of May and we expect a better performance this month.

Volatility Trading

Volatility trading contributed -4bps to the performance of the fund this month.

This month saw a subtle resurgence of volatility themes, accentuated by geopolitical tensions in the Middle East and shifts in interest rates, reflecting a less dovish stance by central banks.

Consequently, realized volatility moved in line with market expectations, while implied volatilities remained stable. This stabilization is remarkable after several months of decline.

In this environment, we maintained our long gamma positions in line with market conditions and identified opportunities to rebuild volatility exposure, particularly in the dispersion space.

However, our negative PnL for the month was due to the build-up of inventory, which resulted in bid-offer spreads crossing and increased risk exposure.

Warrant arbitrage

Warrant arbitrage was flat in April.

Equity strategies

In April, the equity strategy suffered a loss of -78bps. This was mainly due to a difficult environment for the risk arbitrage universe, which experienced a number of setbacks.

We mentioned last month that DS Smith had attracted interest from two buyers, Mondi and International Paper. The market was expecting a bidding war between the two contenders and the stock was trading at a significant premium to the terms of both expressions of interest. Unfortunately, Mondi decided to pull out, with two consequences: DS Smith stock fell to a price reflecting a standard risk arb discount to the International Paper offer while Mondi, which had been used in part to hedge the position, rallied significantly.

In the luxury sector, the FTC sued to block Tapestry's bid for Capri and the market anticipates that the transaction is very unlikely to close.

The takeover of US Steel by Nippon Steel continues to face complexities amid persistent political opposition from the US.

On a more positive note, the Applus takeover is coming to an end, with a sealed-envelope auction between the two bidders resulting in a 16% improvement on the terms of the previous offer.

As we write, corporate activity seems to be picking up slightly: BBVA has made an approach to buy Banco Sabadell and BHP has made an indicative offer for Anglo American.

Credit strategies

Credit long / short

The credit books contributed +10bps this month.

Credit special situations

Credit special situations was up this month (+105bps) with a few items helping performance: Solocal announced an agreement to reorganize its capital structure, including a partial repayment of their revolving credit facility (RCF), Orpea announced results for 2023 and Atos received an indicative offer from the French government for one of its business units.

Trading

Trading contributed +1bp in April.

Macro trading was flat in April. In our systematic trend strategy, gains from rising interest rates slightly outweighed losses in equity indices and individual stocks while gains in commodities, which have usually been a reliable performer since the beginning of the year, were affected by the sharp correction in certain soft commodity futures, which is still ongoing. Overall, the portfolio appears well-balanced and has managed to make a small profit despite market weaknesses.

B. DIRECT INVESTMENTS OTHER THAN BG FUND

On top of its investment in BG Fund, BGHL has other investments. As of 30 April 2024, the net asset value of these investments represents less than 1.00% of the net asset value of BGHL.

Rasa Malta, S.A.P.I. de C.V. ("Rasa")

Rasa is a holding company structured as a private equity fund in terms of fees and organisation and managed by BK Partners. BGHL holds Rasa shares through Campastros, S.L.U., a wholly-owned holding company in Spain. Rasa is dedicated to investing in land, hotels and high-end resort developments in Mexico. Rasa's main asset is a majority interest in ACTUR, a private company owning the land developing assets. ACTUR's other shareholders are Mexican public institutions.

In July 2020, Rasa made a cash tender offer to buy back its own shares, for a price per share of US\$0.12270. The valuation of BGHL's investment in Rasa shares was marked down on 31 August 2020, using the US\$0.12270 per share price as the estimated fair value of the Rasa shares. This price represents a circa 80% discount to the latest published NAV per share.

Hedge Funds Liquidation Stress Tests

Stress tests' scenarios have been improved in order to take into account liquidity issues. This scenario aims at reflecting, to some extent, how the fund would react in a distressed market environment (as was the case in late 2008). These stress tests combine the three following adjustments:

- Small, Mid and Large caps adjustment

In certain market conditions, beta may become much higher than its level in normal market conditions and thus the hedging of such positions may not be effective. To address this kind of circumstance we apply a corrective factor to the beta of small, mid and large caps respectively. Since April 2019, the corrective factors have been calibrated on the amplitude of the stresses by looking at worst historical scenario since 1987.

- Risk arbitrage adjustment

The risk of risk arbitrage positions is taken into account differently in case the market drops by more than 10%. We consider that one third of risk arbitrage positions will collapse.

- Liquidity adjustment

An average discount (realized in 2008) is applied to bond, convertible bond (including mandatory convertible bond) and loan prices in case credit spreads widen by more than 25%.

Mandatories: Adj. price = Max(Shifted Price – 5% * Max(Credit spread shift – 25%, 0), Parity)
