

## ENDEAVOUR ANNOUNCES TRANSACTION IN OWN SHARES

**London, 18 August 2022** – Endeavour Mining plc (LSE:EDV, TSX:EDV) (“the Company”) announces it has purchased the following number of its ordinary shares of USD 0.01 each from Stifel Nicolaus Europe Limited.

These share purchases form part of the Company’s buy-back programme announced on 17 March 2022.
