Dear Mr. Sperling:

As you know, we represent the Plaintiff in the above referenced matter. Plaintiff's complaint asserts a cause of action for tortious interference with prospective business relations, based upon your client through its Amazon Music portal having engaged in shadow-banning, in which Amazon Music has blocked Plaintiff's music from being played, requested or featured as a similar artist.

I have unsuccessfully attempted to discuss this matter informally with you. Plaintiff is requesting that you advise your client of their responsibilities to preserve relevant evidence and take appropriate steps to ensure that such records are preserved for the duration of the above referenced litigation, pursuant to their obligations under F.R.C.P. Rules 26(a)(1)(A)(ii), as well as F.R.C.P. Rules 34 and 37(e) and relevant Second Circuit caselaw. More specifically, pursuant to F.R.C.P. Rule 37(e), we request that the following categories of electronically stored information be preserved and protected for use in this litigation:

- 1. The Metadata logs related to Amazon Standard Identification Number (ASIN) B0041A1P4U from August 1, 2024 through and including the present, including all interval edits and metadata changes to the aforesaid ASIN number.
- 2. Complete profile snapshots from August 1, 2024 through the present, including all metadata, station links and playlist mapping related to Amazon Standard Identification Number (ASIN) B0041A1P4U.
- 3. All Algorithm Audit Trails including but not limited to all algorithmic rules and filters, applied to Amazon Standard Identification Number (ASIN) B0041A1P4U from August 1, 2024 through and including the present.
- 4. All Station Play Logs and/or Play Data for the Marc Mysterio Station and/any stations which Amazon Standard Identification Number (ASIN) B0041A1P4U was identified as a similar artist for, including but not limited to the Tayor Swift Station and Neon Tom Station from August 1, 2024 through the present.
- 5. All IT system changes tied to Amazon Standard Identification Number (ASIN) B0041A1P4U from August 1, 2024 through the present, including but not limited to commands, timestamps, staff IDs, and any "Related Artists" restore(s).
