

Progress on share buyback programme

ING announced today that, in line with the launch of its €1,744 million share buyback programme announced on 1 October 2021, the company has repurchased 3,451,361 shares during the week of 1 November 2021 up to and including 5 November 2021.

The shares were repurchased at an average price of €13.36 for a total amount of €46,116,383.43. The total number of shares repurchased under this programme to date is 35,036,143 ordinary shares at an average price of €12.91 for a total consideration of €452,199,853.08. To date approximately 25.93% of the maximum total value of the share buyback programme has been completed.
