



## IBA – ACQUISITION OF OWN SHARES

Louvain-la-Neuve, Belgium, April 7<sup>th</sup>, 2026 – 6 PM CET – In accordance with article 8:4 of the Royal Decree of 29 April 2019 executing the Belgian Code on Companies and Associations, Ion Beam Applications SA (“IBA”) hereby discloses information in relation to its share buyback program announced on February 2<sup>nd</sup>, 2026.

Under this program, IBA has requested a financial intermediary to repurchase up to 400,000 IBA ordinary shares on its behalf under the terms of a mandate with validity until September 30<sup>th</sup>, 2026 (included), effective as from February 3<sup>rd</sup>, 2026, to cover the company’s obligations under long-term incentive plans for management and certain members of its personnel.

In the framework of this share buyback program, IBA repurchased 16,000 IBA shares on Euronext Brussels in the period from March 30<sup>th</sup>, 2026, up to and including April 3<sup>th</sup>, 2026, as follows:
