JDE Peet's share buyback periodic update August 11, 2025

JDE Peet's (EURONEXT: JDEP), the world's leading pure-play coffee company, today announced that it has repurchased 167,402 shares in the period from August 4, 2025 up to and including August 8, 2025.

The shares were repurchased at an average price of EUR 25.77 per share for a total consideration of EUR 4.3 million. These repurchases were made as part of the EUR 250 million share buyback programme [announced on March 3, 2025](#).

The total number of shares repurchased under this programme to date is 4,999,196 ordinary shares for a total consideration of EUR 101 million. More details on the progress of the buyback programme are available [here](#).
