Arcadis reports transactions under its current share buyback program

Amsterdam, May 14, 2021 – Arcadis (EURONEXT: ARCAD), the leading global Design & Consultancy organization for natural and built assets, has repurchased 67,013 of its own shares in the period from 7 May up to and including 13 May 2021 at an average price of €36.31. The consideration of this repurchase was €2.4 million. The repurchase is in accordance with the share buyback program to cover existing obligations under employee incentive plans and to cover commitments for stock dividend, as announced on 19 February 2021.

The total number of shares repurchased under this program to date is 840,074 shares for a total consideration of €26.9 million.
