Klövern AB (publ), Reg. No. 556482-5833 ("Klövern" or the "Issuer") today announces its invitation to the holders of the bonds described below under "Purchase price" (the "Bonds") (including any beneficial owners who hold their Bonds via nominees or custodians) (the "Bondholders") to tender their Bonds for purchase by the Issuer for cash up to a nominal amount of SEK 400 million (the "Tender Offer") subject to the satisfaction of the New Financing Conditions and other conditions (as defined below) being met. The Issuer has appointed Danske Bank A/S, Danmark, Sverige Filial ("Danske Bank"), Nordea Bank Abp ("Nordea") and Swedbank AB (publ) ("Swedbank") to act as dealer managers (the "Dealer Managers") in connection with the Tender Offer.

# Purchase price

## **Deadline**

### **New Financing Conditions**
