

Capital Increase in Genmab as a Result of Employee Warrant Exercise

Company Announcement

COPENHAGEN, Denmark; November 16, 2021 – [Genmab A/S](#) (Nasdaq: **GMAB) will increase its share capital by 17,862 shares as a consequence of the exercise of employee warrants.**

The increase is effected without any preemption rights for the existing shareholders of the company or others. The shares are subscribed in cash at the following price per share of nominally DKK 1:

250 shares at DKK 337.40,
1,825 shares at DKK 466.20,
1,250 shares at DKK 636.50,
87 shares at DKK 815.50,
2,000 shares at DKK 939.50,
125 shares at DKK 962.00,
1,317 shares at DKK 1,032.00,
9,557 shares at DKK 1,050.00,
100 shares at DKK 1,145.00, and
1,351 shares at DKK 1,432.00.

Proceeds to the company are approximately DKK 17.2 million. The increase corresponds to approximately 0.03% of the company's share capital.

The new shares are ordinary shares without any special rights and are freely transferable negotiable instruments. The new shares give rights to dividends and other rights in relation to the company as of subscription. The new shares will be listed on Nasdaq Copenhagen after registration with the Danish Business Authority. The capital increase is expected to be finalized shortly.

Pursuant to section 32 of the Danish Capital Markets Act No. 2014 of November 1, 2021, it is hereby announced, that the total nominal value of Genmab A/S' share capital after the capital increase is DKK 65,702,915 which is made up of 65,702,915 shares of a nominal value of DKK 1 each, corresponding to 65,702,915 votes.
