

## Completion of the Third and last Tranche of Stellantis 2024 Share Buyback Program and Weekly Report (September 27- October 2 2024)

AMSTERDAM, October 3, 2024 - Stellantis N.V. ("Stellantis" or the "Company") announced today that its Third and last Tranche of the 2024 Share Buyback Program announced on August 1, 2024, covering up to €1 billion to be executed in the open market during the period between August 1, 2024 and November 29, 2024 has been completed.

Since August 1, 2024 up to and including October 2, 2024, the Company has purchased a total of 72,041,332 common shares for a total consideration of  $\in$  999,999,880.

During the period between September 27 up to and including October 2, 2024, the Company has repurchased the following common shares:
