Pursuant to Section 38 of the Danish Capital Markets Act (in Danish: “Kapitalmarkedsløven”) and Section 15-16 of the Danish Executive Order on Major Shareholders (in Danish: “Bekendtgørelse om storaktionærer”), Freudenberg Home and Cleaning Solutions GmbH hereby notifies Nilfisk Holding A/S of its holding of shares and voting rights in Nilfisk Holding A/S (trading symbol: NLFSK; identification number / ISIN: DK0060907293).

1. Identity of the shareholder

Freudenberg Home and Cleaning Solutions GmbH exercises its voting rights in Nilfisk Holding A/S directly and in its own name. No other physical or legal person is entitled to exercise voting rights on behalf of Freudenberg Home and Cleaning Solutions GmbH in respect of the shares held in Nilfisk Holding A/S.

2. Threshold exceeding date for transactions

The relevant threshold of 90% was exceeded on 15 April 2026.

3. Change in voting rights and share capital

As of 15 April 2026, Freudenberg Home and Cleaning Solutions GmbH directly holds 26,626,126 shares in Nilfisk Holding A/S, corresponding to 94.47% of the total share capital and voting rights.

The holding of Freudenberg Home and Cleaning Solutions GmbH consists exclusively of directly held shares in Nilfisk Holding A/S. Freudenberg Home and Cleaning Solutions GmbH holds no shares indirectly through controlled entities or other intermediaries.


