

Weekly Report (August 4-10, 2023) on the Second Tranche of Stellantis Share Buyback Program

AMSTERDAM, August 11, 2023 - Stellantis N.V. ("Stellantis" or the "Company") announced today that pursuant to its Second Tranche of the Share Buyback Program announced on June 7, 2023, covering up to €500 million to be executed in the open market during the period between June 7, 2023 and September 7, 2023, it has repurchased the following common shares in the period between August 4 up to and including August 10, 2023:
