

Subsea 7 S.A. Treasury Shares

Luxembourg – 20 April 2022 – Subsea 7 S.A. (Oslo Børs: SUBC, ADR: SUBCY) (the Company) announced that on 20 April 2022, the Company has transferred 30,117 shares held in treasury to satisfy employee share awards under the Company’s Long-term Incentive Plan.

Following the above transfer, the number of common shares held in treasury is 7,004,900 representing 2.33% of the Company's issued common shares. The total number of shares in issue, including treasury shares, is unchanged at 300,000,000.
