## Increased number of shares and votes in BTS Group

STOCKHOLM, SWEDEN - BTS GROUP AB (publ), - a leading global strategy implementation firm, has increased the number of shares and votes in the company. The increase is due to the directed new share issue that was announced in a press release March 5, 2019, and a directed new share issue following conversion of employee stock options.

Following this, the total number of shares in BTS Group has increased to 19,143,439 allocated between 853,800 class A shares and 18,289,639 class B shares. The number of votes amounts to 26,827,639 allocated between 8,538,000 class A shares and 18,289,639 class B shares. After the increase, the share capital amounts to 6,381,146 SEK.

In March, holders of employee stock options under the employee stock option program exercised them for the acquisition of 113,819 new B shares in the company.
