Alexander Lacik, Chief Executive Officer of Pandora A/S, has reported the purchase of 49,568 shares at a total price of DKK 12,260,329.7, and now holds a total of 49,568 shares in the Company.

PANDORA is publicly listed on the Nasdaq Copenhagen stock exchange in Denmark. In 2018, Pandora's total revenue was DKK 22.8 billion (approximately EUR 3.1 billion).
