

Participation notification by BlackRock Inc.

According to Belgian transparency legislation (Law of May 2, 2007), BlackRock Inc. (12 Throgmorton Avenue, London EC2N 2DL, UK) recently sent Syensqo the following transparency notification indicating that it crossed the threshold of 3%. Here is the summary of the move:
