

**JANUARY 2024 ETP MARKET STATISTICS**

Amsterdam, the Netherlands – Flow Traders Ltd. (Euronext: FLOW) releases monthly ETP (Exchange Traded Products) market statistics for January 2024. This refers to general market observations only.

**Highlights**

- In January, *On & Off Exchange Value Traded* was up 10% y/y in EMEA, up 26% y/y in Americas, up 39% y/y in APAC, and up 26% y/y Globally.
- Average volatility, as exemplified by the VIX, was down 34% y/y in January.
