Share Buyback Transaction Details January 9 – 15, 2020

January 16, 2020 - Wolters Kluwer today reports that it has repurchased 93,638 of its own ordinary shares in the period from January 9, 2020, up to and including January 15, 2020, for €6.2 million and at an average share price of €66.69.

These repurchases are part of the share buyback program announced on November 1, 2019, under which we intend to repurchase shares for up to €50 million in the first two months of 2020.

The cumulative amounts repurchased to date under this program are as follows:

For the period starting January 2, 2020, up to and including February 24, 2020, we have engaged a third party to execute €50 million of buybacks on our behalf, within the limits of relevant laws and regulations (in particular Regulation (EU) 596/2014) and the company's Articles of Association.

Repurchased shares are added to and held as treasury shares and will be used for capital reduction purposes or to meet obligations arising from share-based incentive plans.
