

Alm. Brand A/S – Weekly report on share buybacks

In the period 14 January 2019 to 18 January 2019, Alm. Brand A/S bought own shares for a total amount of DKK 3.9 million as part of the share buyback programme of up to DKK 200 million announced on 28 February 2018. The share buy-back programme is expected to run until the end of March 2019. In aggregate, shares of DKK 180.4 million were bought back, equivalent to 90.2% of the overall programme.

Under the share buyback programme, the following transactions were made during week 3:
