

## Subsea 7 share repurchase

Luxembourg - 20 March 2020 - Subsea 7 S.A. (Oslo Børs: SUBC, ADR: SUBCY) today announced that on 20 March 2020 the Company repurchased 49,117 of its shares at an average price of NOK 46.14 per share. This represents approximately 0.02% of the Company's issued share capital.

The shares were repurchased in accordance with the Company's share repurchase programme announced on 25 July 2019.

As at close of business on 20 March 2020 the Company held 2,454,907 treasury shares representing approximately 0.82% of the Company's issued share capital. Total shares in issue, including treasury shares, were 300,000,000.
