

## Capital Increase in Genmab as a Result of Employee Warrant Exercise

### **Company Announcement**

# COPENHAGEN, Denmark; September 10, 2024 – <u>Genmab A/S</u> (Nasdaq: GMAB) will increase its share capital by 11,729 shares as a consequence of the exercise of employee warrants.

The increase is effected without any preemption rights for the existing shareholders of the company or others. The shares are subscribed in cash at the following price per share of nominally DKK 1:

4,623 shares at DKK 1,025.00, 3,656 shares at DKK 1,032.00, 561 shares at DKK 1,050.00, 1,645 shares at DKK 1,334.50, 1,015 shares at DKK 1,432.00, and 229 shares at DKK 1,615.00.

Proceeds to the company are approximately DKK 13.1 million. The increase corresponds to approximately 0.02% of the company's share capital.

The new shares are ordinary shares without any special rights and are freely transferable negotiable instruments. The new shares give rights to dividends and other rights in relation to the company as of subscription. The new shares will be listed on Nasdaq Copenhagen after registration with the Danish Business Authority. The capital increase is expected to be finalized shortly.

Pursuant to section 32 of the Danish Capital Markets Act No. 198 of February 26, 2024, it is hereby announced, that the total nominal value of Genmab A/S' share capital after the capital increase is DKK 66,176,831 which is made up of 66,176,831 shares of a nominal value of DKK 1 each, corresponding to 66,176,831 votes.
