AMSTERDAM, April 26, 2024 - Stellantis N.V. ("Stellantis" or the "Company") announced today that pursuant to its First Tranche of the 2024 Share Buyback Program announced on February 28, 2024, covering up to €1 billion to be executed in the open market during the period between February 28, 2024 and June 5, 2024, it has repurchased the following common shares in the period between April 19 up to and including April 25, 2024:

As of April 18, 2024, the Company held in treasury No. 178,958,553 common shares equal to 4.44% of the total issued share capital including the common shares and the special voting shares.
