Turnover and profitability have both shown double-digit growth for the full year, and fueled by a very strong cash flow, the net financial debt position was reversed into a positive net cash position, further solidifying DEME's financial strength.

In their joint message in the Annual Report, CEO Luc Vandenbulcke and Chairman Luc Bertrand, emphasize: "Over the previous years we took bold decisions to invest in groundbreaking offshore installation vessels such as 'Orion' and 'Green Jade', and in 'Spartacus', the most powerful cutter suction dredger in the world. The results of 2024 demonstrate that this multi-year fleet investment program has paid off."
