

# **IBA – TRANSPARENCY NOTIFICATION**

## (Article 14, paragraph 1 of the law of 2 May 2007 on the disclosure of major holdings)

#### Louvain-la-Neuve, Belgium, December 21, 2023 18:00

### Summary of the notification

IBA (Ion Beam Applications), the world's leading provider of proton therapy solutions for the treatment of cancer, announces that it has to issue a transparency notification, in accordance with Article 14, al. 1 of the Transparency Law of May 2, 2007 on disclosure of major holdings, further to the notification received on December 19<sup>th</sup> 2023.

In its notification, NORGES BANK indicated that following an acquisition or disposal of securities or voting rights, its total shareholding in IBA SA had increased and its shareholding in IBA shares with voting rights had crossed the threshold of 2% on 15/12/2023.
