

## PARTICIPATION NOTIFICATION BY BLACKROCK INC.

**Brussels, Friday, January 24, 2020, 08h30 CEST** --- According to Belgian transparency legislation (Law of May 2, 2007), BlackRock Inc. (55 East 52nd Street, New York, NY, 10055, U.S.A.) recently sent to Solvay a transparency notification indicating that it crossed the threshold of 3%:
