



## IBA – TRANSPARENCY NOTIFICATION

(Article 14, paragraph 1 of the law of 2 May 2007 on the disclosure of major holdings)

### Summary of the notification

IBA (Ion Beam Application), the world's leading provider of proton therapy solutions for the treatment of cancer, announces that it has to issue a transparency notification, in accordance with Article 14, al. 1 of the Transparency Law of May 2, 2007 on disclosure of major holdings, further to the notification received on December 27<sup>th</sup>, 2021.

In its notification, Ion Beam Applications SA has notified, that following an acquisition of voting rights, its total holding in IBA SA has crossed upwards the 2% threshold.
