

# Disclosure of transparency notification (article 14, first paragraph, of the Law of 2 May 2007)

## Notification by BlackRock Inc. of 30 January 2025

### Summary of the notification

Vastned NV has received on 30 January 2025 a transparency notification dated 30 January 2025, which indicates that BlackRock Inc., as a result of the acquisition of shares on 29 January 2025, holds 3.02% of the voting rights of Vastned NV. BlackRock Inc. has thus exceeded the 3% shareholding threshold.
