Novo Nordisk A/S – Share repurchase programme

Bagsværd, Denmark, 23 October 2023 – On 10 August 2023, Novo Nordisk initiated a share repurchase programme in accordance with Article 5 of Regulation No 596/2014 of the European Parliament and Council of 16 April 2014 (MAR) and the Commission Delegated Regulation (EU) 2016/1052 of 8 March 2016 (the "Safe Harbour Rules"). This programme is part of the overall share repurchase programme of up to DKK 30 billion to be executed during a 12-month period beginning 1 February 2023.

Under the programme initiated 10 August 2023, Novo Nordisk will repurchase B shares for an amount up to DKK 5.7 billion in the period from 10 August 2023 to 31 October 2023.

With the transactions stated above, Novo Nordisk owns a total of 40,196,846 B shares of DKK 0.10 as treasury shares, corresponding to 0.9% of the share capital. The total amount of A and B shares of DKK 0.10 in the company is 4,510,000,000 including treasury shares.

Novo Nordisk expects to repurchase B shares for an amount up to DKK 30 billion during a 12month period beginning 1 February 2023. As of 20 October 2023, Novo Nordisk has since 1 February 2023 repurchased a total of 36,140,324 B shares of DKK 0.10 at an average share price of DKK 562.83 per B share of DKK 0.10 equal to a transaction value of DKK 20,340,911,156.

Our purpose is to drive change to defeat serious chronic diseases, built upon our heritage in diabetes.
