## KPN reports on progress of € 250m share buyback

KPN has repurchased 11,835,000 KPN ordinary shares in the period from 20 April to 24 April 2026. The shares were repurchased at an average price of € 4.64 per share for a total consideration of € 55.0m. These repurchases are part of the € 250m share buyback started on 29 January 2026 and reflect KPN's commitment to structurally return additional capital to its shareholders.

The total number of ordinary shares repurchased until 24 April 2026 is 25,025,000 for a total consideration of € 116.4m.
