KPN reports on progress of € 250m share buyback

KPN has repurchased 1,584,000 KPN ordinary shares in the period from 7 July to 11 July 2025. The shares were repurchased at an average price of \in 4.08 per share for a total consideration of \in 6.5m. These repurchases are part of the \in 250m share buyback started on 25 February 2025 and reflect KPN's commitment to structurally return additional capital to its shareholders.

The total number of ordinary shares repurchased until 11 July 2025 is 55,637,738 for a total consideration of \notin 222.6m.
