Growing order book and revenue in New Cavotec

On 5 March 2021, Cavotec communicated a decision to focus resources and make investments in the ports & maritime and industrial markets. As a consequence, a process was initiated to divest the Airports business. From the first quarter 2021, Cavotec reports the groups ports & maritime and industry businesses combined under the name New Cavotec. Airports is reported separately.

- Cavotec opened an office in Malaysia to meet growth in the Asian market.
- Cavotec won a cleantech order valued at EUR 1.2M for a major cruise and ferry terminal in the south of France.
- Cavotec won cleantech orders worth EUR 6.5M from two of the world's largest container shipping lines.

Comment from the CEO

Growing interest in decarbonisation underpins strong development in New Cavotec



We continue to see a strong demand for Cavotec's cleantech solutions to facilitate the decarbonization of the maritime industry. In the third quarter, we signed contracts worth EUR 6.5M for our prefabricated PowerFit shore power connection modules that will be retrofitted to a number of vessels for two of the world's largest container shipping lines. The order is a recognition of our leading position in the market for retrofitting the thousands of ships that need to be made shore power ready in the coming years. We also signed several orders for shore power connection systems for newbuild vessels in recognition of our wide offering in this space.

The fact that shipping lines chose to install our equipment in anticipation of ports around the world to do the same is very encouraging, as well as our dominating market position in this market. The orders send strong signals to ports around the world that their biggest customers plan for a reality in which charging in port will be the new normal.

During the quarter we also secured orders with Port of Stockholm for the first MoorMaster system in Sweden which is estimated to reduce CO2 emissions by up to 5,000 tonnes per year. In fact, a new study by Starcrest Consulting Group shows that automated mooring can reduce carbon emissions in a typical cargo port by tens of thousands of tonnes. If installed at every container port worldwide the carbon dioxide savings alone would be equals to the emissions from a million cars. To help ports make the right decisions we have release a free tool that can be used to estimate the potential fuel savings and emissions reductions from adopting automated vacuum mooring.

The above and other orders resulted in a 20% increase in the backlog for New Cavotec ending at EUR 92.8 M, almost 60% higher than a year ago.

The majority of revenue from these maritime orders will not materialize until 2022 and onwards since the planning cycle in the industry is long. It is against this background encouraging that revenues in New Cavotec, despite the long sales and delivery cycles, increased 3.1% to EUR 29.2 million in the quarter. Strong revenue in Industry and Services contributed to the increase.

Our accelerated focus on investing in activities to solidify our market leading position continued during the quarter. Our focus is on developing our cleantech systems further as well as recruitment of sales and marketing people. Furthermore, we opened a new office in Malaysia to leverage our strong

position in the fast-growing markets for electrification and automation of ports in Asia.

In total the growth investments during the third quarter amounted to EUR 1.3 million. These investments have a short term impact on our profitability, but EBIT adjusted for those growth investments amounted to EUR 2.5 million corresponding to a margin of 8.5%.

The process of divesting the Airports business continues according to plan. The market conditions for the airports industry are demanding. However, going forward, demand for both new build and service is expected to increase, due to expected increase of traveling after the pandemic.

The global focus on sustainability, work place safety and increased efficiency in our markets is only accelerating and we continue to solidify our leading position. The growing demand is a strong sign of our expectations for the future of Cavotec.

Financial Review

July-September 2021

From the first quarter 2021, Cavotec reports its ports & maritime and industry businesses combined under the name New Cavotec. Airports is reported separately. Allocations between the businesses remain unchanged.

New Cavotec

Revenue and Order Backlog

New Cavotec's order backlog increased 20.0% compared to Q221 to EUR 92.8 million. The increased order backlog is explained by new cleantech orders in the ports and maritime sector, predominantly in Asia and Europe. Industry performed well, and the order backlog for Cavotec's service offering grew considerably during the quarter.

During the quarter Cavotec won, among others, an order with Port of Stockholm for first MoorMaster™ system in Sweden, reducing CO2 emissions by up to 5,000 tonnes per year and a key motorised cable reel order for advanced container cranes in Japan. Furthermore, Cavotec won shore power contracts from two of the world's largest container shipping lines and a major cruise and ferry terminal in south of France for a total of EUR 7.7 million.

Revenues increased 3.1% to EUR 29.2 million (28.3). Revenue growth in the quarter was not as strong as the growth in order backlog due to the high proportion of orders to be delivered in 2022. The services share of revenues in New Cavotec during the quarter was 22.1% (20.8%).

EBIT

EBIT amounted to EUR 1.2 million (1.9), corresponding to a margin of 4.0% (6.6%). EBIT margin was impacted by supply chain constraints leading to higher material prices and freight costs as well as the time lag of our own price increases.

EBIT Adjusted for growth investments

EBIT adjusted for growth investments grew to EUR 2.5 million corresponding to a margin of 8.5%.

In 2021 Cavotec announced it would accelerate its focus on cleantech by investing in sales, marketing, engineering and technology to solidify its market leading position. During the quarter the investments amounted to EUR 1.3 million.

Airports

Revenue and Order Backlog

Airports' order backlog decreased -4.7% compared to Q221 to EUR 27.2 million. Going forward, demand for both new build and service is expected to increase, due to expected increase of travelling after the pandemic.

Revenues decreased -16.4% to EUR 7.7 million (9.2). The decrease is mainly explained by continued disruption in the

business due to the Covid – 19 situation resulting in lower orders. Services share of revenues in Airports was 30.0% (22.2%).

FRIT

EBIT decreased to EUR -2.4 million (0.2), corresponding to a margin of -30.8% (2.3%). The lower EBIT is mainly explained by lower volumes.

Total

Revenue and Order Backlog

The order backlog increased 13.3% compared to Q221 to EUR 120.0 million. Revenues decreased -1.7% to EUR 36.9 million (37.5)

EBIT

EBIT decreased to EUR -2.1 million (0.7), corresponding to a margin of -5.8% (2.0%). EBIT was affected by increased costs for recruitment, marketing and development of products, in line with the strategy communicated in May to increase investments in strengthening our leading position and to meet the expected demand.

Profit for the period and earnings per share

Finance costs amounted to EUR -0.4 million (-0.5). Currency exchange differences amounted to EUR 2.0 million (-2.7).

Income tax expenses for the third quarter 2021 amounted to EUR -0.7 million (0.9).

Net result for the period was EUR -1.2 million (-1.5).

Earnings per share basic and diluted amounted to EUR -0.013 (-0.016).

Cash flow

Operating cash flow amounted to EUR -3.6 million (3.5). The decrease is mainly due to the build-up of inventory of EUR 2.4 million as result of the growth in production driven by the improvement in order backlog, and to the payment of EUR 1.5 million as a consequence of an airports customer's unwarranted calling on a performance bond guarantee in the Middle East.

Investing activities amounted to EUR -1.0 million (0.4), mainly related to R&D investments in New Cavotec products, especially in the continued development of our new MoorMaster NxG product.

Cash flow from financing activities was EUR -1.1 million (-1.9), mainly due to repayment of financial liabilities.

Cash and cash equivalents amounted to EUR 9.1 million as of 30 September 2021 (16.0).



JANUARY-SEPTEMBER 2021

Total

Revenue and Order Backlog

Order backlog increased 13.3% compared to Q221 to EUR 120.0 million. Revenues decreased -6.3% to EUR 110.7 million (118.2).

EBIT

EBIT decreased to EUR -2.5 million (4.4), corresponding to a margin of -2.2% (3.7%). The loss is predominantly driven by lower volumes in the airports segment in a disrupted travel market, together with divestment transaction costs of EUR 0.2 million and one-offs of EUR 0.7 million related to the settlement of the US class action in the airports division. New Cavotec's EBIT was in line with last year despite lower revenue.

EBIT Adjusted for growth investments

EBIT adjusted for growth investments amounted to EUR -0.6 million, corresponding to a margin of -0.5%. In the first half of 2021, Cavotec launched a transformation to accelerate focus on cleantech by investing in sales, marketing, engineering and technology to solidify the market leading position. The investments amount was EUR 1.9 million.

Profit for the period and earnings per share

Finance costs amounted to EUR -1.2 million (-1.2).

Currency exchange differences amounted to EUR 3.9 million (-2.2).

Income tax expenses for the first nine months 2021 amounted to EUR -0.9 million (-0.3).

Net result for the period was EUR -0.7 million (0.7).

Earnings per share basic and diluted amounted to EUR - 0.007 (0.008).

Operating cash flow amounted to EUR -6.5 million (6.1M).

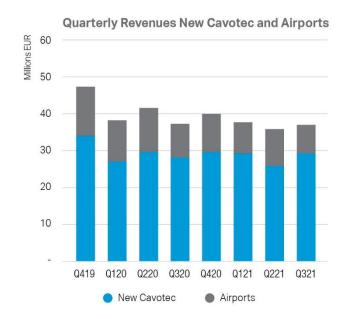

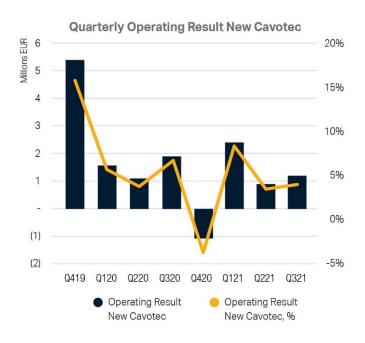

General information

Cavotec is a leading cleantech company that designs and delivers connection and electrification solutions to enable the decarbonization of ports & maritime, industrial and airports applications. Backed by more than 40 years of experience, our systems ensure safe, efficient and sustainable operations for a wide variety of customers and applications worldwide. Our credibility comes from our application expertise, dedication to innovation and world class operations. Our success rests on the core values we live by: Integrity, Accountability, Performance and Team Work. Cavotec's personnel represent a large number of cultures and provide customers with local support, backed by the Group's global network of engineering expertise. Cavotec SA, the Parent company, is a limited liability company incorporated and domiciled in Switzerland and listed on Nasdaq Stockholm Mid Cap.

These unaudited Financial Statements have been approved by the Board of Directors for publication on 28 October 2021.

Basis of preparation of Financial Statements

This quarterly report was prepared in accordance with IFRS, applying IAS 34 Interim Financial Reporting. The same accounting and valuation policies were applied in the most recent annual report. The amendments to the standards that became applicable for the current reporting period did not have an impact on Cavotec accounts. The condensed interim financial statements should be read in conjunction with the annual financial statements for the year ended in December 2020. The preparation of quarterly financial statements requires management to make judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets and liabilities, income and expenses. Actual results may differ from these estimates.

Segment information

Operating segments have been determined on the basis of the Group Management structure in place and on the management information and used by the Chief Operating Decision Maker (CODM) to make strategic decisions. On 5 March 2021, the Group announced that it would initiate a process to divest the airports business. To facilitate the divestment process the Group has changed the organizational structure and reporting to the CODM. The Segment information presented in Q321 report reflects the two new operating segments:

New Cavotec - development and manufacture of innovative automation and electrification technologies for the global ports and maritime sectors and development and manufacture products for industrial applications, such as cranes, energy, processing and transportation, surface and underground mining, and tunnelling.

Airports - development and manufacture of fully integrated gate and remote apron solutions for Airports.

Q320, 9M20 and FY2020 comparatives have been restated based on the new segments to enhance comparability.

Legal disputes

In the long running litigation matter in California, the Group's net accounting position is unchanged during the quarter and our view remains that we have accounted for the most likely eventualities of the process. The latest development in the case supports this position.

In June 2021, Cavotec settled a class action legal suit in the USA for an amount equivalent to EUR 0.7 million. The class action relates to employment matters. We are expecting the settlement to be approved by a local court in early 2022.

Noteworthy risks and uncertainties

Cavotec's significant risks and uncertainties are divided into three categories, market, credit and liquidity risks. In these categories, there are both risks due to political and macroeconomic trends and specific risks directly linked to business carried out by the Group. Market risk includes currency and interest rate risk. Credit risk includes the risk of

managing our customers and other receivables while liquidity risk includes the management of cash in a diverse, global group.

Covid - 19 Update

The COVID-19 pandemic has had a significant effect on the global economy. The impact on Cavotec is mainly delays in decisions from customers on new orders as well as delays in taking deliveries of product or services. At the date of this report all Cavotec facilities are open. As of September 30, 2021, there is no significant impact on any balance sheet items.

Forward looking statement

Some statements in this report are forward-looking, and the actual outcome could be materially different. In addition to the factors explicitly discussed, other factors could have a material effect on the actual outcome. Such factors include, but are not limited to, general business conditions, fluctuations in exchange rates and interest rates, political developments, the impact of competing products and their pricing, product development, commercialisation and technological difficulties, interruptions in supply, and major customer credit losses.
