Ferratum welcomes listing on the SDAX

Helsinki/Berlin, June 19, 2015 - Ferratum Oyj (ISIN: FI4000106299, WKN: A1W9NS; together with its consolidated subsidiaries hereinafter "Ferratum Group" or "Ferratum"), an international provider of mobile consumer loans and a pioneer in the field of "financial technology", will be listed on the SDAX index, of the German Stock Exchange as of June 23, 2015. Following its successful initial listing on the Prime Standard on February 06, 2015, Ferratum Group has risen only four months later into the small-cap index, which consists of the 50 largest publicly traded companies below the MDAX.

Jorma Jokela, founder and CEO of the Ferratum Group, welcomes the company's listing in the index: "We are very pleased about our inclusion in the SDAX so soon after our IPO. The listing makes Ferratum even more attractive to investors." Dr. Clemens Krause, CFO of Ferratum Group, adds: "We see excellent opportunities for Ferratum Group also in the fiscal year 2015 and beyond. All in all, we have created very good prerequisites to continue our profitable business growth."

Ferratum's customers can utilize digital media to apply for consumer credit in amounts varying between EUR 25 and EUR 2,000. Moreover, Ferratum offers installment loans to small businesses with a successful track record for 6 to 12 months. Managed by its founder Jorma Jokela, Ferratum has expanded rapidly since it was founded in 2005: Ferratum has 1.0 million active and former customers who have been granted one or more loans in the past and 3.0 million total user accounts in its database (as of 31 March 2015). Ferratum is represented in 22 markets (including France) and employs 383 people as of 31 December 2014.
