 A principle shall enjoy the right to divest, at any time, of the power of attorney whereas an authorised waive it. Power of attorney expires: 1) upon the expiry of the term of power of attorney; 2) upon the divestment of attorney by a principal; 3) upon the waiver of power of attorney by an authorised agent; 4) upon term on a legal person which was vested with power of attorney; 5) upon he death, recognition of legal in partial capacity or absence of a natural person who was vested with the power of attorney. A principal shall have to notify an authorised agent and the third persons known to the principle and establishment and maintenance of relations with whom the power of attorney has been granted, a divestment of power of attorney. An Agent must present a report to the principal about his activities and give an account of every received in his mission to the principal. Power of attorney shall grant to a Principal same right just as they are exercised by a shareholder rep by this power of attorney.
