EVS reports update of share buyback program

EVS Broadcast Equipment reports that the following transactions, conducted within the framework of the share buyback program announced on October 24, 2018, took place between January 27, 2020 and January 31, 2020.

As of January 31, 2020, and since the start of the buyback program, EVS has bought 337,821 shares at an average price of EUR 20,9650, representing in total EUR 7,082,427.

After aforementioned transactions the total number of own shares amounts now to 416,469 shares as of January 31, 2020 (including 93,144 shares already held by the company before the start of the share buyback program and taking into account the 14,496 shares distributed as part of the employees profit sharing plan as approved by the May 2019 OGM).
