("Stellantis" or the "Company") announced today that pursuant to its Second Tranche of the Share Buyback Program announced on June 7, 2023, covering up to \notin 500 million to be executed in the open market during the period between June 7, 2023 and September 7, 2023, it has repurchased the following common shares in the period between July 28 up to and including August 3, 2023:
