

Publication of a transparency notification

On 29 June 2022, NV Bekaert SA crossed the threshold of 5% downwards. Stichting Administratiekantoor Bekaert and NV Bekaert SA together crossed the threshold of 40% downwards. The passive crossing of thresholds resulted from the cancellation of the shares purchased by Kepler Cheuvreux on behalf of NV Bekaert SA under the share buy-back program through 28 June 2022.
