Banco Comercial Português, S.A. informs about Interim report on the transactions conducted under the Share Buy-Back Programme

As previously disclosed to the market, Banco Comercial Português, S.A. (“**BCP**” or the “**Bank**”) started trading own shares in the context of the Share Buy-Back Programme approved by the Bank in accordance with the terms and conditions described in the announcement regarding the start of trading under the Buy-Back Programme disclosed by BCP on 27 May 2026 (the “**Buy-Back Programme**”).

In this context, pursuant to articles 5(1)(b) of Regulation (EU) 596/2014 of the European Parliament and of the Council of 16 April 2014 and 2(3) of Commission Delegated Regulation (EU) 2016/1052 of 8 March 2016, BCP informs that, in the period from 04 June 2026 to 12 June 2026, inclusive (the “**Period**”), it has purchased under the Buy-Back Programme, through J.P. Morgan SE, as the financial intermediary in charge of the execution of said programme, 8,765,844 ordinary shares representing the Bank’s share capital in Euronext Lisbon regulated market (XLIS), as detailed in the table below (aggregated information):
