## Publication relating to a transparency notification

(article 14, paragraph 1, of the Act of 2 May 2007 relating to the publication of important participations)

### Summary of the notification

As at 13 March 2020 Intervest Offices & Warehouses (hereinafter 'Intervest') received a transparency notification dated 12 March 2020 from Patronale Group nv and Patronale Life nv, indicating that it holds 5,07% of the voting rights in Intervest following the acquisition or transfer of securities conferring voting rights or voting rights, and has therefore exceeded the notification threshold of 5%.
