NAV per share in USD: 2513.96

NAV per share in EUR: 2321.72

The performance during July is 0.06% in USD. The year-to-date net performance is 3.15% in USD.

Assets under management (AUM) was 338.9 million USD.

The NAV per share in EUR, 2321.72, is calculated as the USD NAV divided by the EUR/USD exchange rate as of 31 July 2024 which was 1.0828.

To calculate the present EUR NAV, divide the most recent USD NAV with the current EUR/USD exchange rate.
