

Share Buyback Transaction Details October 23 – October 29, 2025

Alphen aan den Rijn – October 30, 2025 - Wolters Kluwer (Euronext: WKL), a global leader in professional information solutions, software and services, today reports that it has repurchased 392,600 of its own ordinary shares in the period from October 23, 2025, up to and including October 29, 2025, for €43.8 million and at an average share price of €111.53.

These repurchases are part of the share buyback program announced on February 26, 2025, under which we intend to repurchase shares for €1 billion during 2025.

The cumulative amounts repurchased in the year to date under this program are as follows:

For the period starting July 31, 2025, up to and including November 3, 2025, we have engaged a third party to execute €363 million of buybacks on our behalf, within the limits of relevant laws and regulations (in particular Regulation (EU) 596/2014) and the company's Articles of Association.

Shares repurchased are added to and held as treasury shares and will be used for capital reduction purposes through share cancellation.
