

Trading by management and close relations of management

Pursuant to Article 19 of Regulation (EU) No 596/2014 of 16 April 2014 on market abuse (market abuse regulation) and Commission Delegated Regulation (EU) 1052/2016 of 8 March 2016, Novozymes hereby publishes the following transactions under ISIN code DK0060336014, Novozymes B shares (ticker symbol NZYM B).

Today, Novozymes has entered into an agreement to purchase 765,000 B shares (nominal DKK 2.00) of a value of DKK 244,012,050 from Novo Holdings A/S. This transaction is part of Novozymes' 2019 share repurchase programme of up to a total of DKK 2 billion to be executed during 2019. The transaction price is DKK 318.97 per share and has been calculated as the volume weighted average market price from November 1 to November 5, 2019 in the open window following the announcement of Novozymes' financial results for the first nine months of 2019.

This sale has been conducted pursuant to Novo Holdings A/S' previously announced intention to maintain its relative holding of approximately 25.5% of the total common stock which was the level prior to Novozymes' capital reduction of March 29, 2019 (Company announcement No. 1, January 24, 2019).
