

## **Oxurion Receives Transparency Notification from Atlas Special Opportunities LLC**

**Leuven, BELGIUM, Boston, MA, US – June 1, 2023 – 7.00 PM CET** [Oxurion NV](#) (Euronext Brussels: OXUR) a biopharmaceutical company developing next generation standard of care ophthalmic therapies, with clinical stage assets in vascular retinal disorders, today announced that, pursuant to Belgian Transparency legislation<sup>1</sup> it has received a transparency notification as follows:

Oxurion received a transparency notification on May 26, 2023, from Atlas Special Opportunities LLC indicating that as of May 24, 2023, it held 32,301,799 shares of the then outstanding 824,233,449 shares, and therefore crossed below the threshold (5%) by virtue of the sale and acquisition of voting securities.
