AkzoNobel share buyback (July 8, 2019 – July 12, 2019)

AkzoNobel (AKZA; AKZOY) has repurchased 595,700 of its own ordinary shares in the period from July 8, 2019 up to and including July 12, 2019, at an average price of \in 82.52 per share. The consideration of the repurchase was \in 49.16 million.

This is part of a repurchase program announced on February 13, 2019. The total number of shares repurchased under this program to date is 20,541,200 ordinary shares for a total consideration of €1,602.90 million.

AkzoNobel intends to repurchase common shares up to a value of $\in 2.5$ billion as part of a total $\in 6.5$ billion being distributed to shareholders following the sale of the Specialty Chemicals business. The share buyback is due to be completed by the end of 2019.
