#### **OVERVIEW**

BGHL is a closed-ended investment company which invests in BG Fund, Boussard & Gavaudan's flagship fund with 17 years of track record.

BGHL's investment objective is to deliver an annual return, net of fees, of 400 to 600 basis Share price €21.30 (discount to NAV: 19%)

points above the risk-free rate over the business cycle, irrespective of market performance. The risk-free rate is "capitalized EONIA". BG Fund is driven by bottom-up fundamental and event catalyst research, combined with

extensive multi-asset arbitrage and derivative expertise. Typically, investment ideas are catalyst driven with a focus on special situations and events.

Capital is dynamically allocated to the firm's best ideas and these ideas are categorized into four main types of strategies: Equity, Volatility, Credit and Trading strategies.

## II. OVERVIEW

Boussard & Gavaudan Holding Limited ("BGHL") is a Guernsey closed-ended investment company and is registered with the Dutch Authority for the Financial Markets as a collective investment scheme under article 1:107 of the Dutch Financial Markets Supervision Act. BGHL invests its assets in order to provide exposure to multiple alternative investment strategies managed by the Investment Manager. The investment objective is to produce long-term appreciation of its assets. BGHL seeks to achieve this by investing in BG Fund ("the Fund"). In addition, a proportion of the net assets of BGHL may, at the discretion of the Investment Manager, be invested in other hedge funds and financial assets selected by the Investment Manager. BGHL aims to generate a target NAV annualized return of Eonia capitalized + 400/600 bps over the business cycle, net of all fees.

## V. BGHL COMPOSITION

BGHL is invested in BG Fund (net of an amount retained by BGHL for working capital and other requirements).

As of 1 March 2021, 99.50% of BGHL net asset value is invested in BG Fund. BGHL has a maximum exposure limit to BG Fund of 110%. The remained BGHL net asset value is made up of direct investment and cash.

## A. BG FUND

BG Fund continued its steady returns delivering another positive month in February up +0.54% (USD A estimate). While the Eurostoxx 50<sup>®</sup> Total Return recovered its January losses ending up +4.54% for the month, equity markets in general experienced a significant rotation in the second half of February as rising bond yields triggered a rotation from growth and momentum into cyclicals and value.

Credit markets tightened slightly with iTraxx Crossover<sup>®</sup> (S34) finishing February at 265bps (4bps tighter), and implied volatility decreased moderately with VStoxx<sup>®</sup> ending the month at 26.9%, down from 29%. Overall sentiment is constructive as vaccine distribution continues to improve, albeit more slowly in some regions than others. The outlook for corporate activity in Europe remains strong. We expect this picture to continue to improve as economies re-open, although there is scope for further volatility in markets and this remains priced into the relatively high levels of implied vol.

#### COMMENTARY

#### Volatility strategies

## Mandatory convertible bond arbitrage

Mandatory convertible bonds contributed +9bps this month with performance mainly due to a general positive repricing in a market with relatively low liquidity. Although there was no primary activity during the month we are hopeful that current levels of corporate and capital market activity will lead to new issues in due course.

## Convertible bond arbitrage

Convertible bonds (excl. mandatories) contributed +10bps to the performance of the fund in February. Both primary and secondary markets remained relatively quiet as they were in January, however there were a few notable issues.

JustEat issued €1.1bn in two new tranches, leaving four actively traded tranches in the market. Nexi also re-tapped the CB market with its second issue in less than a year. Finally, AMX issued a new convertible which is exchangeable into KPN. None of these new issues were particularly successful: despite surplus cash available within both long-only CB funds and hedge funds, a wait-and-see mode still seems to be prevailing. During the month we took profits on several positions.

Volatility trading strategies posted +15bps to the performance of the fund this month.

The gap between realised and implied volatility remains very elevated. In addition to demand for puts and calls by investors looking to protect portfolios or create convex upside participation, we have started to see straddle sellers looking to monetise the realised/implied spread in what are perceived to be range bound markets. Long gamma positions have remained painful to carry in most asset classes and especially on equities, however we managed to offset the negative carry of these positions by actively trading around them.

Significant contributors to positive performance this month have been from rate vol positions that captured the sharp sell-off in bonds, along with a repricing higher of volatility in FX vol exposure, mainly linked to the rates moves.

## Warrant arbitrage

Warrant and SPAC arbitrage contributed +34bps in February. During the month we continued to take profit on announced deals.

## Equity strategies

In February, equity strategies detracted -25bps overall. Risk arbitrage and special situations delivered positive returns, while performance was dragged down by value-with catalyst strategies.

Special situations and risk arbitrage finished the month +31bps, despite a disappointing outcome on G4S. As mentioned in December, the G4S situation looked attractive with two strategic buyers, GardaWorld and Allied Universal, competing to buy the company. The market was expecting a final round of auction, organised by the Takeover Panel, in February and the stock was trading at a 7-10% premium to the best bid from Allied. At the last minute, GardaWorld announced they would not participate in the auction, paving the way for Allied to buy the company. The shares subsequently fell to a slight discount to the Allied Universal bid, leaving us with a healthy profit on the position since inception but markedly down for the month.

This disappointment aside the rest of the portfolio more than compensated for this loss, in particular our investment in Corelogic. The market had been waiting for firm offers for the company since the end of October. The first offer came from a PE consortium, followed by a counteroffer from Costar Group. The stock finished the month up +13%.

Our portfolio of fundamental investments in 'value-with-catalyst' companies suffered in February. Rising rates triggered a further rotation into cyclical from growth names, and into large cap out of mid cap. Among others this impacted our positions in some utilities, and more specifically renewable energy names which significantly underperformed, having previously been beneficiaries of the low rate environment. Several tech positions, that had previously benefited from the work-from-home theme, suffered from the reopening economy thematic.

## Credit strategies

## Capital Structure Arbitrage

Capital structure arbitrage was flat in February.

## Credit long / short

Credit strategies contributed +18bps and continued to show an excellent performance despite the overall monthly credit spread compression. In the first half of the month, the Crossover tightened by approximately 35bps and our strategies followed the index tighter, however when long-dated yield moves sent jitters through the credit market, our strategies remained very resilient, with some names even seeing further yield compression, such as Casino and Vallourec.

## Credit special situations

Credit special situations contributed positively delivering +22bps to the performance of the fund. KCA Deutag was a material contributor and benefited from improved sentiment for the oil market along with increased investor interest in the high cash coupon (9.875%) on the reinstated debt for this business that demonstrated the resilience of its cash flow generation through the crisis.

## Trading

Trading strategies overall contributed -29bps in February, mainly impacted by the Equity Quantitative Strategy. The strategy had a solid start to the month but suffered in the second half as growth and momentum were impacted by the sell-off in rates in Europe and in the US, with 10-year swap rates up +25bps and +36bps respectively over the month.

The CTA strategy saw strong gains in commodities, particularly in base metals, but these were offset by losses on rate positions leading to a small net negative for the month. The gradual decline in Treasuries accelerated towards the end of February, even impacting short-term contracts which had previously been more resilient. It is interesting to note that the model is now short some long-term contracts on US T-Bond, Canadian Bond, and JGB.

## B. DIRECT INVESTMENTS OTHER THAN BG FUND

On top of its investment in BG Fund, BGHL has other investments. As of 26 February 2021, the net asset value of these investments represents less than 1.00% of the net asset value of BGHL.

## Rasaland Investors ("RLI")

Rasaland Investors ("RLI") RLI is a Malta-based holding company structured as a private equity fund in terms of fees and organisation and managed by BK Partners. RLI is dedicated to land, hotels and high-end resort developments in Mexico. RLI's main asset is a majority interest in ACTUR, a private company owning the land developing assets. ACTUR's other shareholders are Mexican public institutions.

In December 2020, RLI returned US\$0.27730 per share to its shareholders, by way of a capital reduction. RLI funded the distribution using the proceeds of the sale of its minority interest in the publicly-traded company RLH Properties.

In July 2020, RLI made a cash tender offer to buy back its own shares, for a price per share of US\$0.12270 (post distribution price compared to US\$0.40 pre-distribution). Shareholders, representing approximately 11.71% of the share capital, elected to tender their RLI shares. BGHL elected not to participate.

The valuation of BGHL's investment in RLI shares was marked down on 31 August 2020, using the US\$0.12270 per share price as the estimated fair value of the RLI shares. This price represents a circa 80% discount to the latest published NAV per share.

## **Hedge Funds Liquidation Stress Tests**

Stress tests' scenarios have been improved in order to take into account liquidity issues. This scenario aims at reflecting, to some extent, how the fund would react in distressed market environment (as was the case in late 2008). These stress tests combine the three following adjustments:

#### Small, Mid and Large caps adjustment

In certain market conditions, beta may become much higher than its level in normal market conditions and thus the hedging of such positions may not be effective. To address this kind of circumstance we apply a corrective factor to the beta of small, mid and large caps respectively. Since April 2019, the corrective factors have been calibrated on the amplitude of the stresses by looking at worst historical scenario since 1987.

#### Risk arbitrage adjustment

The risk of risk arbitrage positions is taken into account differently in case the market drops by more than 10%. We consider that one third of risk arbitrage positions will collapse.

#### Liquidity adjustment

An average discount (realized in 2008) is applied to bond, convertible bond (including mandatory convertible bond) and loan prices in case credit spreads widen by more than 25%.
