



## JDE Peet's share buyback periodic update April 22, 2025

JDE Peet's (EURONEXT: JDEP), the world's leading pure-play coffee and tea company, today announced that it has repurchased 40,000 shares in the period from April 14, 2025 up to and including April 17, 2025.

The shares were repurchased at an average price of EUR 20.40 per share for a total consideration of EUR 0.8 million. These repurchases were made as part of the EUR 250 million share buyback programme <u>announced</u> on March 3, 2025.

The total number of shares repurchased under this programme to date is 3,521,614 ordinary shares for a total consideration of EUR 65.3 million. More details on the progress of the buyback programme are available <u>here</u>.
