## KPN reports on progress of € 200m share buyback

KPN has repurchased 2,000,000 KPN ordinary shares in the period from 22 April to 26 April 2024. The shares were repurchased at an average price of  $\leqslant$  3.39 per share for a total consideration of  $\leqslant$  6.8m. These repurchases were made as part of the  $\leqslant$  200m share buyback started on 1 February 2024, and are part of KPN's commitment to structurally return additional capital to its shareholders.

The total number of ordinary shares repurchased to date is 50,006,611 for a total consideration of  $\leq 165.8$ m.
