2. CURRENCY HEDGING OF SHARE CLASSES AND NAME CHANGE

The general part A of the Prospectus and the sub-fund specific part B of the Prospectus will be updated to reflect that all equity and blend sub-funds offer hedged share classes upon specific investor request. These hedged share classes will bear an "H" in their name and are subject to currency hedging by using financial derivative instruments such as forward foreign exchange transactions and/or currency swaps.

Concerning the fixed income sub-funds, the active share classes in a currency other than the relevant sub-fund's reference currency are already subject to currency hedging. The fixed income sub-funds will also offer unhedged share classes upon specific investor request.
