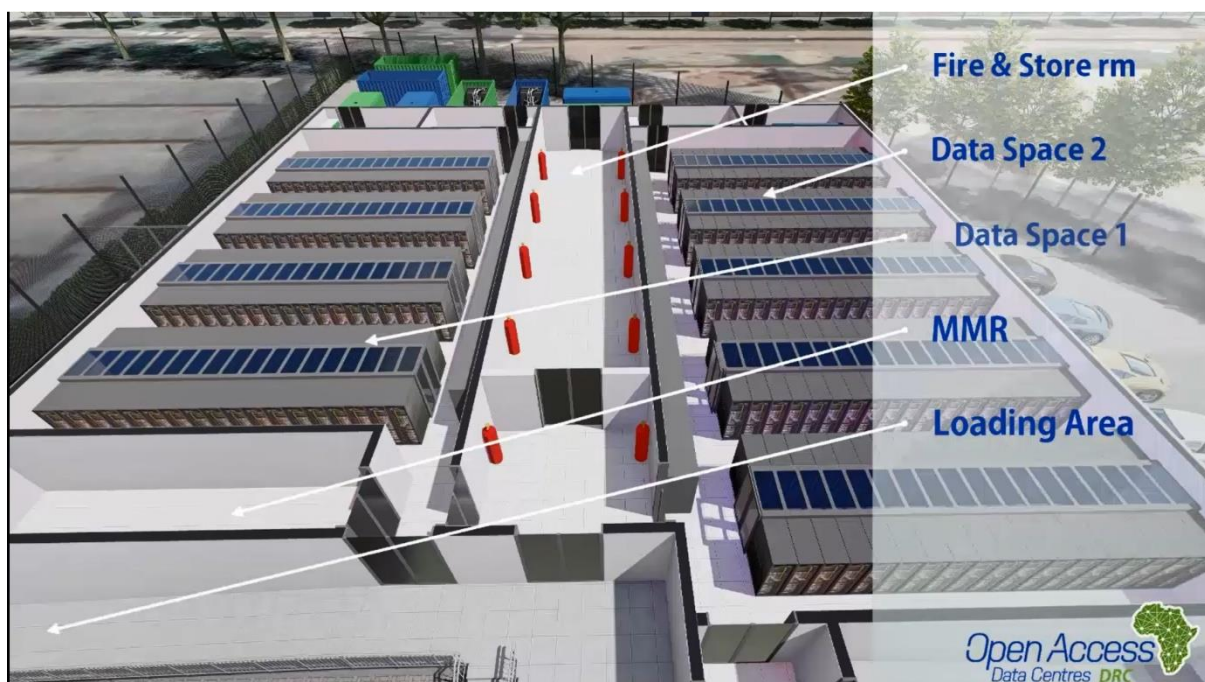

Open Access Data Centres (OADC) and **TEXAF** partner for data centre¹ rollout in DRC

Leading African data centre operator, **Open Access Data Centres (OADC)**, a **WIOCC Group** Company, and **TEXAF**, a major investor in the economy of the Democratic Republic of Congo (DRC), are partnering to build and operate data centres in the DRC.

The first data centre will be located in the central business district of Kinshasa, within **TEXAF's SILIKIN VILLAGE**, which, in 2023, will be the largest hub in Central Africa for digital activities. The data centre is expected to be operational from the 1st quarter of 2023. The facility will be carrier-neutral and open access, which will maximise interconnection opportunities for all customers, and it will be designed and operated to international standards², such as Uptime Institute Tier III, ISO 9001 and PCI-DSS.

As the first carrier-neutral data centre in the DRC, the facility will be extremely well placed to meet the needs of cloud operators, content providers, telecoms operators and internet service providers, as well as key verticals including finance, institutional clients and Government.



¹ A data centre is a critical part of the internet infrastructure. It hosts the data and connects the networks that businesses and consumers use every day.

² Tier III data centres have multiple paths for power and cooling, redundant systems and an expected uptime of 99.982% per year.



This initiative is particularly timely with both Google's Equiano and the Facebook-led 2Africa subsea cables due to land on the Atlantic coast of the DRC within a year. Together, they will bring a huge increase in availability and reliability of international internet connectivity in Western DRC.

The impact of **OADC** and **TEXAF**'s data centre on the digital development of the DRC cannot be understated. It will

- improve reliability and speed of access to the ever-growing volumes of data needed by local banks, telcos, government agencies, as well as supporting data sovereignty initiatives
- enable local delivery of global content - improving latency, optimising utilisation of international capacity and lowering carbon footprint
- embody carrier-neutral principles that will increase competition and contribute to the expected decrease in cost of internet connections for the Congolese people and companies
- thereby become a major enabler for the emergence and further development of a digital ecosystem in DRC
