

Just inaugurated prestigious office project Greenhouse Collection at the Singel, welcomes first tenants

At a prime location in Antwerp, Interinvest delivers a state-of-the-art renovation project of over 14.000 m² of future-proof office space with a sustainable redevelopment.

Antwerp, 16 November 2022. Interinvest Offices & Warehouses (hereafter Interinvest) welcomes Kangaroot and Realis as the first tenants in the newly opened prestigious office project Greenhouse Collection at the Singel. This project is in line with the #connect2022 strategy which puts sustainable value creation with its own team first and translates in the office market into a reorientation towards more future-oriented buildings in cities with a student population.

Kangaroot and Realis both occupy around 560 m² respectively and sign a 6/9 contract. Kangaroot will move in from the end of March 2023 and Realis has been renting since mid-October 2022.

In addition to the classic facilities and services that can also be found in the existing Greenhouse hubs in Berchem, Diegem and Mechelen, such as co-working, serviced offices and private offices, Greenhouse Collection goes one step further with a smart office environment and a smart meeting centre with extensive, premium-level services led by a real master of services.
